Crime Stoppers mission is to assist Houston area law enforcement agencies in facilitating the arrest and filing criminal charges by making rewards available to persons who furnish information which leads to the arrest and filing of charges.

Crime Stoppers of Houston operates 713-222-TIPS, a telephone tip line. Information about criminal activity is received and transferred to law enforcement for immediate action. Callers are promised anonymity and cash rewards of up to \$5,000 in exchange for their accurate crime tips. Our organization provides a safe forum for citizens to report crime in their neighborhoods and schools without the fear of retaliation. We are the eyes and ears of law enforcement in the community. - 2016 Accomplishments: 414 suspects arrested, 24 murders solved, 21 campus crimes solved, 545 cases solved and \$329,000 cash rewards paid to 420 tipsters. In addition to the restricted cash received by court fines to pay tipsters, area law enforcement agencies, television stations, advertisers and utility providers donated services valued at \$2,007,583 during 2016.

The CSOH Safe School Program has successfully educated students in middle and high schools throughout Harris County since 1997 and in 2013 elementary schools were added to this outreach. The elementary program focuses on educating students Pre K - 5th grade on citizenship, respect and safety. Since 1997, our Safe School director has visited 1,187 schools and trained 962,479 students resulting in the solving of 1,784 campus crimes including 987 drug crimes, 31 thefts, 11 arsons, and 15 terroristic threats. In addition to this, tips to Crime Stoppers have led to the confiscation of 250 weapons -- 69 guns, 151 knives, and 30 other types of weapons. This program does not generate revenue; it is sponsored by designated and undesignated grants and donations to CSOH.

In keeping with our mission to solve and prevent crime, CSOH offers free programs to the community to engage people in conversations about crime and public safety through our Safe Community Program. A series of educational and awareness events are conducted throughout the year to give citizens the tools and resources needed to keep their families safe and free of crime. Citizen empowerment and education are central to the Safe Community Program's approach to crime prevention. These programs do not generate revenue and are funded by undesignated donations and donations designated to programs and initiatives such as Human Trafficking, Domestic Violence, Identity Theft, Retail Theft and Animal Cruelty.

- B. The Chairperson of the Board shall be the Chairperson of the Executive Committee and shall preside over all meetings of the Executive Committee;
- C. The Executive Director of the Corporation shall be an ex-officio member of the Executive Committee;
- D. A quorum shall be 50% of the membership of the Executive Committee;
- E. The Executive Committee will meet when called by the Chairperson, with notice. In lieu of meeting in person, the members of the Executive Committee may be polled by telephone or by email on items affecting the Corporation, as determined by the Chairperson.
