### LEGISLATIVE EFFORTS

One of the key components of victim advocacy is being able to enact legislative changes to enhance victim's rights and public safety. Last session, we were able to pass into law what is now known as The Sir Romeo Bill. Usually for every piece of legislation there is always a catalyst for change and little 4 year-old Sir Romeo's case merited crafting a new statute. Here is the backstory that led to the creation of the 'Sir Romeo Law':

- In May 2018, 4 year-old Sir Romeo Milan was indiscriminately shot while watching TV with his grandmother by a stray bullet.
- He spent over six months in the hospital recovering. Upon recovery, his family was apprehensive about him returning to the same residence where he was shot.
- I was contacted by Sir Romeo's family to see if they qualify for relocation expenses under the Crime Victim Compensation Fund.
- Sadly, I told them only two categories of victimization qualify for relocation expenses: Sexual Assault and Domestic Violence. I advised them we needed to enact a Bill to create a Law to allow families like theirs to become eligible for relocation expenses.
- My research indicated no other State had such a statute. State Representative Garnet Coleman and Senator Boris Miles agreed to sponsor the Bill.
- Texas became the first State in the nation to enact a law allowing families whose children were the victims of attempted murder to apply for relocation funds.
- Sir Romeo's legacy will last for eternity for being a positive catalyst for change.



### **2021 LEGISLATIVE GOALS**


- **Enhance Criminal Penalties for defendants** convicted of the offense Deadly Conduct when it involves 'Celebratory Gunfire'.
- Create a statute to charge offenders with a crime when they remove/tamper/destroy their ankle monitor.
- Allow the Texas Board of Pardons and Paroles discretion on all cases being considered for Parole not to review for release from 1 - 5 years as currently statutorily allowed in all offenders convicted of violent offenses.

We will continue to keep everyone updated as to how you can assist us once the Legislative session begins in January 2021.

### **TIP LINE PROGRAM**

The Tip Line Program continues to be a national crime solving system and aims to equip and motivate all citizens to report crime. Through collaboration with more than 70 local and federal law enforcement agencies, the Tip Line has proven its success in solving and preventing crime in the Greater Houston Area.

### HARRIS COUNTY CRIME TRENDS

### FEATURED CASES

The rising crime rates in Houston are alarming to our staff at Crime Stoppers of Houston. We are dedicated to not only uncovering crippling crime trends, but also working to create positive change. Our team is working around the clock to provide innovative public safety solutions to our entire community and we hope you will join us in doing the same.

In July 2020, two defendants were charged with Murder and Capital Murder. Both victims were murdered in cases involving domestic violence. Both defendants were out in the community on multiple bonds and had violated their conditions of bond. The timelines of these cases are outlined below.

### **CITYWIDE CRIME STATISTICS**

The following statistics are based on the reporting of Houston Police Department and research done by Crime Stoppers staff members:

Between May 19, 2020 - July 21, 2020

we have seen:



- 2% decrease in burglary commercial
- 15% decrease in robbery commercial
- 21% decrease in sexual assault cases
- 24% increase in aggravated assault cases

Since 2018. over 50 people have been killed in Harris County by defendents on Felony bonds, multiple bonds or PR bonds.

### BREAKDOWN OF DEFENDENTS RESPONSIBLE FOR **53 MURDERS AND RELATED OFFENSES**

- Defendants out on PR bond 11
- Defendants out on felony bond 4
- Defendants out on multiple felony bonds 10
- Defendants were on deferred adjudication and 4 felony bond simultaneously
- Defendants are on parole, 1 is a fugitive 3
- 3 Defendants are wanted fugitives
- 1 Defendant charged with murder received felony bond while on probation, defendant charged with second murder and is currently a wanted fugitive

### **BOND REFORM UPDATE**

Crime Stoppers supports Misdemeanor Bond Reform. We recognize and support the need for Criminal Justice Reform. What we do not support is when public safety is placed at risk because career habitual offenders are continuously released back to the community despite being charged with multiple violent crimes.

How is this happening? From our perspective, this is the crux of the problem: Misdemeanor court judges are bound by a Federal Court ruling that removes cash bail for most defendants charged with misdemeanor offenses. District court judges who handle felony cases are not. This means, when a defendant is released on a felony bond and then arrested on a new charge, the district judge has the discretion whether or not to revoke the original bond or grant a new bond giving the defendant the opportunity to be returned to the community.

Time and time again we are seeing the same defendants being arrested for violent crimes including murder and yet are still being granted and released on a new bond.

Over 40 defendants released on either felony bond, multiple bonds and or a PR bond have been charged with Capital Murder, Murder, Intoxicated Manslaughter and Failure to Stop and Render Aid - Fatality in less than 2 years in Harris County.

### The Murder of Chi Le Timeline

 Curtis Holliday granted a felony bond in for Continuous Family Assault of Chi Le

While on felony bond, Holliday charged with violating a protective order against Chi Le. Several bond violation reports were filed in court, however his bond was not revoked.

Ms. Le warned officials that if she went missing, the offender would be responsible for her disappearance.

Holliday removes his ankle monitor; Chi Le goes missing.

• Chi Le's body found murdered in a commercial freezer at the business address of Curtis Holliday.

• Her two small children no longer have a mother.

• Curtis Holliday charged with the Murder of Chi Le.

### The Murder of Kimberly Robinson Timeline

• The offender was granted a PR (Personal Recognizance) Bond for Assault of a Family Member in November 2019.

• The offender granted another PR Bond for the same offense. The offender was granted a Felony Bond for Tampering with a Government Record four days later.

The District Attorney's Office stated in court documents the defendant was a threat to the community and was a flight risk. Despite the warnings, the defendant was still allowed to post

 Kimberly Robinson shot to death while in bed. Kimberly's 4 year-old daughter was also shot but survived. Kimberly's 5 children no longer have a mother.

Cedgadrick Harris is charged with the Capital Murder of Kimberly Robinson.
