Each tipster is given a number and goes to the bank to pick up an envelope with their cash reward in it. Each month there are rewards that are unclaimed, so if they are not picked up within two months, the money is returned to the account and put in escrow for six months. After six months, the unclaimed amounts are moved back into the Rewards Fund.

In 2025, SSI expanded safety access and visibility statewide by launching new instructional content on consent, AI awareness, digital literacy, and mental health; producing a new TIPS reporting video; and delivering Spanish-language virtual training series for educators across all 20 Education Service Centers. SSI strengthened partnerships through 12 new MOUs, supported new Safe School programs in additional counties, distributed more than 2,300 backpacks to Title I schools across multiple regions, and engaged over 100 student volunteers while assembling 3,000+ Child ID Kits. During the year, SSI reached 245,892 students with face-to-face education, 17.6 million students via digital education, 33,543 school staff and law enforcement professionals, and 327,951 parents and community members, contributing to a combined 12+ million people reached since inception across the Safe School and Safe Community Institutes in 82 Texas counties, demonstrating measurable, scalable impact in school safety and prevention education.

Form 990, Part III, Line 4b, Program Service Accomplishments:

In 2025, the Tip Line received 11,869 tips which assisted law enforcement in solving 359 cases ranging from Capital Murder to Fugitive Warrants that led to 201 suspects being charged and/or arrested. These tips resulted in the seizure of 33 weapons and \$526,109.85 in illegal drugs seized plus \$712,530 in stolen property/cash recovered. The approved Reward payout to 180 men, women and students totaled \$204,150. CSOH received \$43,597 of restricted cash from court fines to help pay tipster rewards and three area law enforcement agencies donated services valued at \$1,969,000 to process and investigate the anonymous tips.

Form 990, Part III, Line 4c, Program Service Accomplishments:

In 2025, SCI achieved significant statewide impact by providing statistics to aid Texas lawmakers writing public safety legislation, launching a redesigned GGRC crime data website, expanding The Balanced Voice with a fully Spanish-language series, and creating the Texas Victims' Rights and Support Hub set to launch in 2026. SCI also delivered new content addressing emerging risks, including a 12-part AI video series and adult mental health resources, hosted its largest volunteer event to date with 400 students assembling Child ID Kits, and established 10 new partnerships. Through digital platforms, research tools, advocacy, and direct services, the Safe Community Institute reached more than 1 million community members in 2025 and contributed to a total organizational reach of 4.4 million people, reinforcing SCI's role as a statewide leader in prevention, victim support, and public safety innovation.

- A. The Executive Committee has all powers of the Board of Directors between meetings of the Board of Directors;
 - B. The Chairperson of the Board is the Chairperson of the Executive Committee and presides over all meetings of the Executive Committee;
 - C. The CEO of CSOH is an ex-officio member of the Executive Committee;
 - D. A quorum consists of 50% of the membership of the Executive Committee;
 - E. The Executive Committee meets when called by the Chairperson with notice. In lieu of meeting in person, the members of the Executive Committee may be polled by telephone or by email on items affecting CSOH as determined by the Chairperson.
